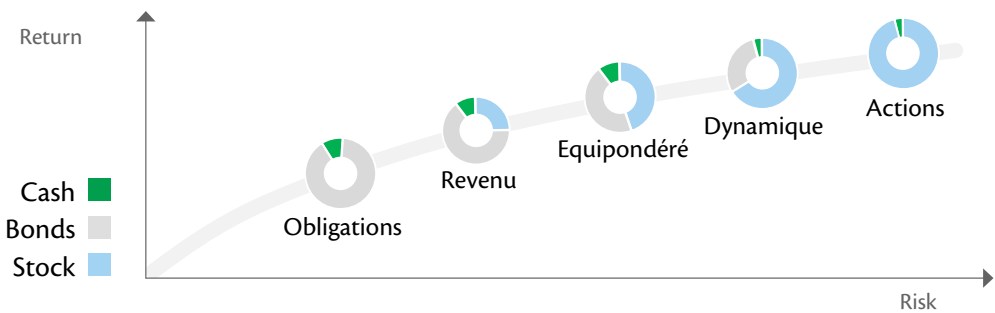

Asset allocation in line with your risk profile

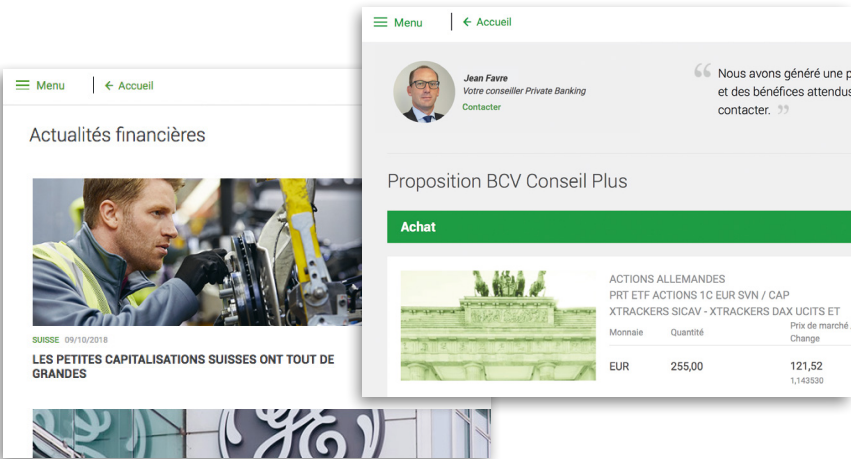
